## **Position Summary:**

This position assists and cooperates fully with the Picking Supervisor. Responsible for proper grading and scaling of mushrooms according to instruction.

## **Expected Outcomes:**

### 1. Duties & Responsibilities

- a. Familiar with Standard Operating Procedures GF001SOP, 002 & 003.
- b. Properly scales and grades mushrooms QUICKLY as they are received from the growing rooms.
- c. Ensure that mushrooms are scaled and cooled in the shortest possible time once picked.
- d. Properly and promptly makes necessary computer entries to record picking records.
- e. Report any apparent problems to the Picking Supervisor---i.e. poor practices being exercised within the growing rooms and rest of the facility.---poor product quality, poor hygiene practices on the part of anyone, etc.
- f. Ensure that all facility doors are kept closed at all times. These include exterior doors and doors to growing rooms.
- g. Ensure that no unauthorized visitors are permitted in the facility.
- h. Adheres to all pre-established operating procedures. These include procedures for food safety, employee safety, proper sanitation practices, scaling and grading equipment maintenance, and any other procedures that may be implemented from time to time. Attends to training courses as may be required.
- i. To be supportive of all supervisory decisions and instructions.
- j. Assists in preparing customer orders with product that has been properly graded.
- k. Ensures that all "checklists" have been duly completed and submitted as instructed.
- 1. Ensure that pre-established standard operating procedures are properly adhered to by all personnel. These include procedures for food safety, employee safety, proper sanitation practices, warehouse equipment maintenance, and any other procedures that may be implemented from time to time.
- m. Ensure that proper quality control standards are adhered to for outgoing product; this includes product quality and grading, in addition to standards for product packaging, labeling, etc.
- n. Participate in all required health and safety education and training.
- o. Work safely, and encourage you co-workers to do the same.
- p. Use all required personal protective equipment and clothing.
- q. Correct any unsafe conditions or immediately report them to your supervisor.
